Transforming an education center – Worked alongside 31 volunteers to remodel an abandoned 2,000 sq. ft. building into a vibrant learning center in Tortuga, Nicaragua, which now contains 3 classrooms of 600-700 sq. ft. each. Provided transportation and supplies for the remodeling, including building materials, plumbing, roofing, electrical wiring and fixtures, doors, locks and paint. Also provided and installed 10 desktop computers. Worked with 25 local teachers to get feedback on the needs for the new center, which now provides classes to 50 students in computers, literacy and English, and provides training and support to 25 teachers.

4b (Code: n/a) (Expenses \$ 4,871 including grants of \$ -0-) (Revenue \$ -0-)
Providing community education workshops – Provided 14 community workshops to youth and their families on topics related to watershed science, water quality testing, waste management, reforestation techniques, causes of mangrove degradation, and integrating youth into community planning. 15-20 youth attended each of the workshops, which were led by consultant Henningston Hodgson. Three of the workshops were led in collaboration with 6 environmental research fellows and faculty from the National Autonomous University of Nicaragua.

Developing the capacity of two community water associations – Worked with 2 water associations in the communities of Tortuga and Ostional (Nicaragua) to better manage their water resources and increase the supply of potable water to more residents. This included facilitating 10+ workshops and bringing the water associations together with government officials, which resulted in their receiving free piping and water meters. Provided the Ostional association with technical training to install 114 water meters to 100% of the households in the community, resulting in potable water being available 24 hours a day to all households (whereas previously it was available for only 9 hours per day).
