Provided 40 hours of technical training in computer technology to 69 youths and 11 educators in the communities of La Tortuga and El Ostional, Nicaragua.

Provided 80 students a minimum of 1,000 hours' access to our computer lab in La Tortuga, Nicaragua.

In partnership with the National Autonomous University of Nicaragua (Nicaragua's primary university), created a nationally recognized, accredited certificate in computer competency.

Supported 6 youth fellows in the communities of La Tortuga and El Ostional, Nicaragua. This included financial support from us and mentorship from our staff and from faculty members of the National Autonomous University of Nicaragua with the aim of developing environmentally sound plans for water management and waste disposal in the two above-mentioned communities.

Developed 3 environmentally sound plans for improving water management and waste disposal in the communities of La Tortuga and El Ostional, which were adopted and implemented by the local communities and local governments.

Conducted 6 technical training workshops for 120 youths in La Tortuga and El Ostional -- consisting of 40 hours of training -- in the areas of water, waste and forest management. The trainings were led by our program director in Nicaragua and by two faculty members from the National Autonomous University of Nicaragua, Managua.

Trained 25 educators in teaching strategies and methods in El Ostional, Nicaragua. Conducted over a 4-day period (comprising 32 training hours), the program was led by our program director in Nicaragua and two of our advisory council members (one of whom holds a doctorate in education from the University of Texas at San Antonio and the other a doctoral candidate in education at the University of California, Santa Cruz).
